The following are the rules of the raffle:

1. A limit of 3000 tickets will be sold.
2. Tickets are \$50 per ticket paid in full in cash or debit/credit card (fees apply).
3. Purchases must be made in person to the club or one of its representatives listed on our website at www.pugetsoundflyers.org
4. Raffles tickets can only be sold in person within the State of Washington.
5. Any person age 18 or higher can purchase a ticket in his/her name, a group, a club or a company.
6. Drawing of the Raffle will be held on June 1st, 2019 at the offices of Puget Sound Flyers at 2909 100th St SW, Suite A, Everett, WA 98204.
Details of the exact time of drawing will be announced prior to this date on our website at www.pugetsoundflyers.org
7. Winner need not be present at the time of the drawing.
8. The winner will be notified via email, phone and by US Certified Mail to claim their prize.
9. The winner will have 7 days after notice was sent to claim the prize.
10. The winner must sign a hold harmless agreement, publicity, media and photo releases and necessary paperwork for the transfer of the prize.
11. The winner is responsible for taking possession of the prize within 30 days.
12. The Winner does not need to be a certificated pilot at time of the awarding of the plane.

13. Plane will include an aircraft file with all documents and logs covering Airframe, Engine, Propeller and compliance with all Airworthiness Directives and Service Bulletins at time of Award. A full detail of the aircraft work is provided at the time of Ticket purchase.
14. Plane will be transferred to winner with a current Annual Inspection and Transponder Certification.
15. Winner is responsible for all the costs of registering this aircraft with the Federal Aviation Administration and the WA State Department of Transportation Aviation Division. At the time of transfer of possession, Puget Sound Flyers, Inc will execute an FAA form 8050-2 and send to the FAA Aircraft Registry.
16. Winner is responsible for payment of sales/use tax to the State of Washington or their home state if other than Washington.
17. Winner is responsible for federal income tax payments as a result of winning the prize. IRS Notice 1340 details the responsibilities of the Puget Sound Flyers and the winner.
18. The Prize Aircraft is awarded "As Is" with no warrantee or guarantee implied. The aircraft winner will be provided with an Aircraft File providing all administrative and legal documents pertaining to the aircraft and its refurbishment.
19. Puget Sound Flyers provides for 1 hour of flight training to a person holding a Recreational Airman Certificate or higher.
20. Winner will be responsible for arranging their own hangar or tie down at the airport they will move the plane to.
21. Entry constitutes permission to use the winners name for future promotions and publicity purposes without compensation except where prohibited by law.
